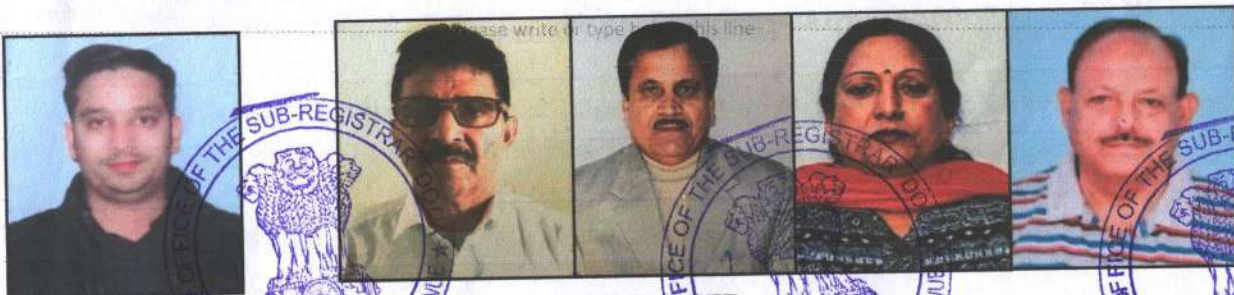
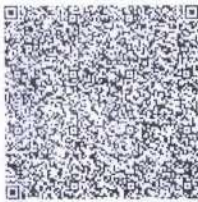

Hereinafter, jointly called the "Trustees" which expression shall for the time being of these present and/or survivor or survivors of any of them (and their successor or successors in office of the other part).

Whereas, the "Settler" is desirous of creating a Trust, with himself as Managing Trustee/Chairman, by setting apart & establishing a fund for charitable aims and purposes hereinafter expressed.

AND

Whereas, the "Trustees" has at the request of the "Settler" agrees to act as "Trustee" upon the terms and provisions hereinafter contained.

**NOW THIS INDENTURE WITNESSETH AS UNDER :**

**1. TRUST FUND:**

Whereas the settler had been longing to create and establish an educational charitable trust, the settler had already delivered & made over to the "Trustee" a sum of Rs. 50,000 (Rupees Fifty Thousand only) with intent to part with all his rights, title, interest & claim therein & vest the same in the "Trustee" to have & hold the same & all other property or properties that may be required out of the same together with all accumulated income thereof, hereinafter referred to as "Trust Fund" for charitable objects & purposes & uses hereinafter expressed with the powers & terms & conditions herein contained. The Trust Fund shall be spent for charitable purposes & objects.

**2. NAME OF THE TRUST:**

The name of the trust shall be **Om Parkash Chandail Educational and Charitable Trust.**

**3. REGISTERED OFFICE:**

The registered office of the Trust shall be situated at **Khasra No. 818 min, Khata No. 14 & Khewat No. 1 ground floor, Near Govt. Degree College Nagri Doda W. No. 17, Tehsil & Distt. Doda, J&K- 182202, or such other place or places**

which the Trustees may agree from time to time for better achievement of objects of the Trust.



4. **AREA OF OPERATION:**

The area of operation for the trust shall be in India in General & Jammu and Kashmir State in particular.

5. **AIMS AND OBJECTS:**

The objects for which the Trust is established are as under:-

(A) **MAIN OBJECTS**

- i) To propagate knowledge and thereby promote the cause of learning, education, research, training, new technologies, social welfare and human resources development for different ages and target groups based on the principles of autonomy, excellence, quality and self-sufficiency.
- ii) To set up and manage quality based and progressive colleges (both professional and technical), schools, research centers, training institutes and specialized centers for guidance and counseling in fields such as engineering, technical education, vocational, continuing, lifelong and distance education, adult and non-formal education, fine arts and culture propagation, special education, social welfare, community education, educational innovation and reforms and allied educational areas. To take over existing and running educational institutions.
- iii) To undertake degrees/diplomas/fellowship/research titles and other awards, under the seal of the institute, of individual fulfilling the eligibility criteria set for the purpose.
- iv) To undertake, co-ordinate and encourage research and developmental work in different disciplines to extend the frontiers of knowledge with a view to provide educational / technical expertise and consultancy to individuals, governments and organizations in these areas.

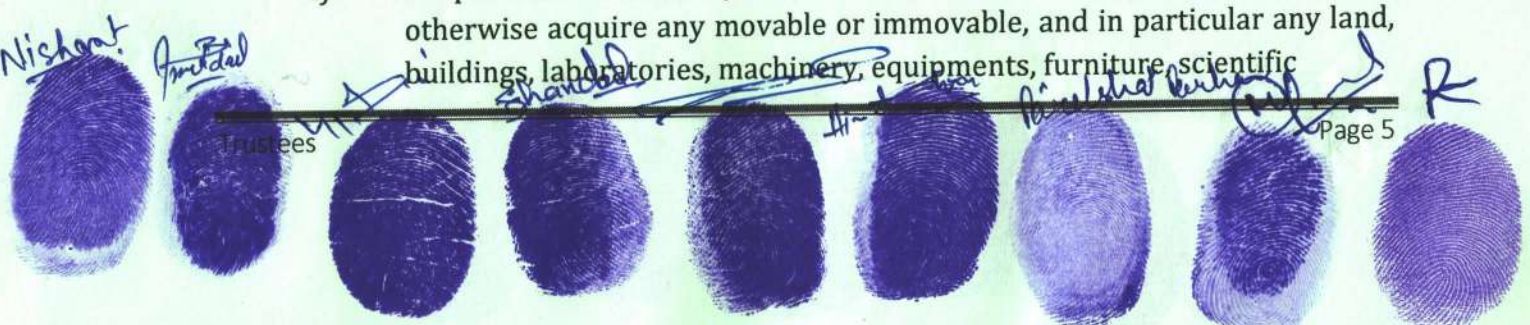

- v) To set up specialized centers and run appropriate programmes for the benefit of backward classes, destitute, disadvantaged groups and physically/ mentally challenged etc. for their social, vocational rehabilitation and welfare in rural as well as urban areas.
- vi) To continuously strive for stringent quality assurance by conforming to international quality standards and norms, thereby emerging as one of the leading educational service providers locally and globally.
- vii) To offer programmes and services to the student community which enhance their chances of employability and lead to the multi-dimensional development of their potentialities; creating a pool of skilled / competent manpower to shape as valuable assets to the nation in all walks of life.
- viii) To collaborate and establish symbiotic linkages with individuals, Governments, institutions and organizations of repute which further the cause of the institute.
- ix) To organize application oriented/ vocational and income generating programmes in emerging areas and undertake extension programmes so as to cultivate, promote and develop the spirit of entrepreneurship among youth/ women and thereby contribute to the development of society in general.
- x) To provide need based educational training to individuals of all age groups through distance mode (educational delivery system) in areas that would enhance their professional growth and thereby increase national productivity.
- xi) To start a boarding cum residential school in the name and style of "Swiss International School, Bhaderwah" located at Drudhu, Bhaderwah District Doda (J&K).

**(B) INCIDENTAL AND ANCILLARY OBJECTS**

- i) To purchase or take by way of lease, sublease, gift, exchange, hire or otherwise acquire any movable or immovable, and in particular any land, buildings, laboratories, machinery, equipments, furniture, scientific

record, experimental data, library, apparatus, appliances and any rights or privileges necessary or convenient for the purpose of the Trust and to construct, erect, alter, improve and maintain any building and to manage, develop, sell, demise, let, mortgage, dispose off, turn to account, or otherwise deal with all or any part of the assets and rights of the institute for cash or any other consideration with a view to the promotion of the objects of the institute.

- ii) To receive fees and other charges on different accounts e.g. admission, tuition, games, library, research etc from the students and other target groups as may be fixed from time to time by the Board of Management.
- iii) To apply to the Government, Public Bodies, Urban, Municipal, District, and other bodies, Corporations, Companies or other persons both in India and outside, for and to accept grants of money, equipment, land and buildings, donations, gifts, subscriptions and other assistance with a view to the furtherance of objects of the institution and for that purpose, to enter into requisite agreement, and to conform to the conditions on which such grants and other payments may be received.
- iv) To get the recognition, affiliation and registration for the institute for the fulfillment of its objects and to set up university from the various State Governments, Government of India, Statutory bodies, autonomous bodies and from foreign government and various institutions and authorities in India and abroad.
- v) To invest the money of the institute not immediately required in such securities, shares etc and in such manners as may from time to time be determined by the institute.
- vi) To borrow money for carrying on the objects of the Institute from Banks and other bodies corporate with or without security.
- vii) To safeguard the interest of the students in general of the institute and to grant scholarship, prizes, rewards, and other benefits and financial assistance and awards on all India, regional or local basis to the persons for their outstanding performance in the field of education.

- viii) To open Current, Savings, Fixed deposit and other accounts with Banks and Post offices.
- ix) To establish branches within or outside the UT of Jammu and Kashmir.
- x) To adopt such means of making known the institute as may seem expedient and in particular by advertising in Press, Circulars and Bills and by granting prizes, holding Seminars and Conferences and organizing and participating in annual and other functions.
- xi) To pay all the preliminary expenses of and incidental to the formation and incorporation of the institute out of the funds of the institute.
- xii) To pay salaries, pensions, allowances, gratuities and to provide amenities to employees or ex-employees not being members of the institution and other institutions set up by it.
- xiii) To draw, make, accept, endorse, discount, execute and issues promissory notes, bills of exchange and other negotiable or transferable instruments.
- xiv) To retain and/ or employ skilled, professional and technical advisors and other staff and workers not being members in connection with the objects of the institute and to pay, therefore, such fees or remuneration as may be considered expedient.
- xv) To prepare, edit, print, publish, issue and circulate books, magazines, papers, periodicals, circulars, advertisement and other literary undertaking dealing with or bearing upon various aspects of general, professional and technical education and other areas and disciplines and to establish, form and maintain collections, libraries and collection of literature, statistics and scientific data and other information relating to translate ,compile, collect, publish, lend or sell and to disseminate the results relating thereto. To hold meetings, conferences and to arrange lectures, discourses, seminars, symposium, exhibitions and fairs related with the subject of education for furtherance of all or any of the objects of the institute and to obtain or provide detailed information in respect of the nature of the activities conducted by the institute in furtherance of the interest of the literatures , books and periodicals, study notes, and for that



purposes establish, run and maintain printing press, library, conference hall which the institute may deem fit not on commercial basis.

- xvi) To formulate rules and regulations relating to the day-to-day affairs, working policies, admission policies and financial budget, of the institute and to amend and change them as may be necessary.
- xvii) To establish and maintain separate benevolent fund other than the fund of the institute in order to render proper help in time of need to general public who are sufferers of war, flood, fire, earthquake, disability, handicap, and deprivation or any other accidents, calamities, and for the purpose of any other charitable object.
- xviii) To do all such other lawful things as may be necessary, incidental or conducive to the attainment of the above objects.

Provided that the institute shall not support with its funds or endeavor to impose on or procure to be absorbed by its members or others, any regulation or restriction which, if any object of the institute, would make it a Trade Union.

**(C) OTHER OBJECTS**

- i) To make arrangements for imparting education by correspondence and other means not touching upon the usual method of holding classes.
- ii) To act as and set up bodies for conducting examinations and grant of Diplomas, Certificates, Fellowship and other distinctions. Also to arrange facilities for affiliation of School, Colleges, Training Centers and other Professional and Research Institutes.
- iii) To arrange for exchange of Scholars in between the various institutes, various States and various Countries as also to depute and invest Scholars not in the nature exchange.
- iv) To run themselves or on contract, canteens for purposes of the institution set up by the trust.
- v) To set up Hostels/ Boarding houses for the students, staff of the institutions run by the institute and other concerned with it.

- vi) To amalgamate with any other institute, with or without winding up or in any manner, as provided under law.
- vii) To do all such other things as are incidental or the institute may think conducive to the attainment of its objects.

**6. NON PROFIT ENTITY:**

The Trust shall be nonprofit making in character. All the income(s) and property(ies) of the trust shall be applied solely towards the promotion of its aims and objects as set forth in the Trust Deed and no portion thereof shall be paid or transferred, directly or indirectly, by way of dividends, bonus or otherwise by way of profit to trustees of the trust or any person claiming through any one, or more of such persons. No person shall have any personal claim or any profit whatsoever by virtue of this connection with the "Trustees".

- 7. Provided that nothing herein shall prevent the payment of salary as teacher in the institution or payment of travelling and other out-of-pocket expenses and interest on money lent and rent for premises demised to the institute.
- 8. The settler shall be the Managing trustee till life and shall be Chairman of the Trust and have right to nominate any other trust(s) from time to time. No other trustee shall be added without the consent of the Chairman of the Trust except the trustees for life, the remaining trustees shall retire at the end of every period of 15 years, their place being filled in by the chairman/managing trustee of the trust. However, the managing trustee shall have all the powers to change any of the Trustees in the interest of the smooth running of the trust. In case of vacancy of the trustee due to his/her death or resignation, the managing trustee shall have all the powers to fill the vacancy.
- 9. The chairman whenever needed may call a meeting of the Board by giving a minimum notice of seven days to the Trustees or such shorter notice as is agreed upon by the trustees. Quorum of the Board of "Trustees" for all decisions shall not be less than any four "Trustees". Quorum for the meeting of Board of "Trustees" shall be four, presence of Chairman shall be obligatory to form the quorum. No business shall be transacted at any meeting unless the quorum specified above is present at the time when the meeting proceeds to business. The Chairman shall preside over all the meetings of the Board and shall have powers to regulate the

functioning of the meeting as also to adjourn the meeting from time to time. All the proceedings, matters & questions before a meeting shall be decided by a majority of votes. In case of equality of votes, the Chairman shall have casting vote. Provided however, that notwithstanding anything herein stated no question dealing with acquisition or disposal of Trust property moveable or immoveable shall be decided except with the consent of Chairman of the Board. A resolution in writing circulated amongst all the Trustees & signed by a majority of the Trustees shall be a valid & effectual as if it had been passed at a meeting of the Trustees duly called & convened. A trustee who is unable to present at a meeting of the Trustees may send his views on the agenda in writing & such expression of opinion shall be taken to be his vote on the matter concerned. The minutes of proceedings of every meeting of Trustees shall be recorded in a book to be kept for the purpose & shall be signed by the Chairman of the meeting & shall be conclusive evidence of the business transacted at such meeting.

10. The trustees shall exercise all such powers as may be necessary for achieving the objectives of the Trust & carrying out the affairs of the Trust.
11. The funds of the Trust shall be deposited in Scheduled Banks & Post Offices, the account shall be operated upon by the Chairman singly or jointly with other trustees or by such other trustee empowered by the Board.
12. The accounting year of the Trust shall be 1<sup>st</sup> of April to 31<sup>st</sup> of March each year. On the close of the accounting year, Income & Expenditure account as also the Statement of Affairs of the Trust shall be prepared. An auditor who is qualified to act & appointed by the Board of the Trust shall audit the accounts of the Trust.
12. A person or persons in whom, for the time being any funds or money or other property, moveable or immoveable, of the Trust be vested shall be answerable for any loss arising to the Trust in the Administration or Application of the said funds or sums of money or for damage to or deterioration shall happen by or through him or their will full default or negligence.
13. The Board of Trustees may by a majority decision remove any of the Trustees from the Board who may be found guilty of any misconduct or whose continuance may be determined to be detrimental to the interest of the Trust.
